18B-10-1(k)	LOCEA	Finance	HEPC to report to LOCEA regarding institution compliance with statutory requirements regarding tuition and fee increases and basis for approving or denying.
18B-19-18	LOCEA	Finance	HEPC and CCTCE to annually provide general status report to LOCEA on the progress being made in implementing the statewide capital development plan and on the progress of the governing boards in implementing the objectives of institutions' campus development plans. Pursuant to 18B-1D-8a, information required shall be combined in other reports.
18B-7-16	LOCEA	Human Resources	HEPC and CCTCE to study and develop policies for reductions-in-force, furloughs, issues related to seniority, internal preferences for hiring, define non-classified employee, and the status of grant employees and report findings and recommendations to LOCEA.
18B-7-8	LOCEA	Human Resources	HEPC and CCTCE to prepare annual Human Resources Report Card by December 1, 2020 and every five years thereafter.
18B-7-8	LOCEA	Human Resources	HEPC and CCTCE to report to LOCEA by July 1, 2016 and at least every 5 years on effectiveness of job classification, point factor methodology, and job evaluation plan. Pursuant to 18B-1D-8a, information required shall be included in HR Report Card.
18C-5-7	LOCEA	Financial Aid	Vice Chancellor for Administration to report annually by December 1 to LOCEA on status of HEAPS grant program. Pursuant to 18B-1D-8a, information required shall be included in Financial Aid Comprehensive Report.
18C-7-5	LOCEA	Financial Aid	HEPC to provide annual report concerning PROMISE scholarship recipients. Pursuant to 18B-1D-8a, information required shall be included in Financial Aid Comprehensive Report.
18C-7-5(b)	LOCEA	Financial Aid	HEPC to make annual recommendations to LOCEA to encourage recipients to live and work in WV after graduation. Pursuant to 18B-1D-8a, information required shall be included in Financial Aid Comprehensive Report.

30-7B-7	LOCEA / LOCHHRA	Health Sciences	WV Center for Nursing shall report biennially on its progress in developing a statewide strategic plan to address the nursing shortage in West Virginia.
18B-16-9(c), (d)	LOCEA / LEGISLATURE	Health Sciences	Rural Health Advisory Panel and Vice Chancellor for Health Sciences to report annually to LOCEA and Joint Committee on Government and Finance about status of the rural health initiative. To be included in Health Sciences Report Card.
18B-16-9(e)	GOVERNOR AND LEGISLATURE	Health Sciences	HEPC to report annually to Governor, Senate President, and House Speaker about extent to which rural health initiative goals are being met. To be included in Health Sciences Report Card.
18C-3-4	LOCEA / LOCHHRA	Health Sciences	HEPC to report annually by December 1 to LOCEA and LOCHHRA the number of Nursing Scholarship recipients. Pursuant to 18B-1D-8a, information required shall be included in Financial Aid Comprehensive Report.
18B-1-1e	LOCEA / WVBOE	Policy and Planning	HEPC to report annually to LOCEA and WVBOE the number of public school graduates accepted for enrollment at public institutions whose knowledge, skill, and competency were below expected minimum standards and the areas of deficiency.
18B-1D-8	LOCEA	Policy and Planning	HEPC to complete comprehensive statewide Higher Education Report Card to include data on achieving state goals and objectives as well as information from the statewide masterplan by January 1 annually.
18B-1D-8(i)	LOCEA	Policy and Planning	HEPC and Council to prepare report highlighting trends, progress toward meeting goals and objectives and major areas of concern for public higher education, including medical education.
18B-1D-5	LOCEA	Policy and Planning	Submission of any new master plan every five years to LOCEA for approval.
18B-1D-5	LOCEA	Policy and Planning	HEPC to provide detailed report to LOCEA on meeting master plan at the end of each five-year period.

18B-4-9	LEGISLATURE	Student Affairs	HEPC jointly with CCTCE to submit report annually by September 1 to Legislature regarding progress toward implementing services for student veterans.
18B-4-7	LOCEA	Academic Affairs	HEPC and CCTCE to provide annual report on institutional reauthorization reviews. Information to be made available on websites. Pursuant to 18B-1D-8a, information required shall be included in Higher Education Report Card.
18B-18A-12	LOCEA	Science and Research	HEPC to make annual report to LOCEA on Research Trust Fund, disbursements, expenditures, research funded, outcomes, etc.
18B-18B-2	LOCEA	Science and Research	Science and Research Council to make annual report to LOCEA on status of Strategic State Plan for Science and Technology Research.
